PLEASE READ

GENERAL CONDITIONS OF ENTRY

1. The exhibition will be conducted according to standards and recommended procedures of the Photographic Society of America. This exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to exhibition rules and conditions. Subject matter is not restricted, except as noted for Photojournalism. **The Delaware Photographic Society entry form or a photocopy must be used.** Two forms are attached and others may be photocopied or downloaded from the Society Web site at : www.delawarephotographicsociety.org.
2. Submit one entry form for each section entered and circle its section name. Group entries must include our forms and fees. An entry received without the required fees will not be processed, but will await payment until our closing date. **If no fee is received, the entry will neither be judged nor returned.**
3. Entries must originate as photographs (image-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright. Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates, subject to divisional restrictions.
4. **Prints or slides by the same maker that were accepted in previous Wilmington International Exhibitions, OR IMAGES THAT ARE NEARLY IDENTICAL, may not be entered in the same section.**
5. Entrants should not submit slides or prints that virtually duplicate each other or differ only slightly. Only one of such images will be judged.
6. An entrant's four images will be distributed throughout four rounds of judging.
7. All possible care will be taken to protect entries. However, no responsibility will be assumed for loss or damage to entries in the exhibition or in transit.
8. Entries will be forwarded to another domestic exhibition if so indicated on the entry form and if the necessary address labels are included.
9. The maker's name and address must appear on all items. Prints and slides must also be titled and numbered to agree with the respective forms.
10. Titles will not be read during judging.
11. Notification results, showing judges' scores in accordance with the PSA rules, will be sent by e-mail or postcard to each entrant immediately after the judging. Titles will not be shown on the score results.
12. No acceptance cards will be issued.
13. Acceptances will be reported to the Photographic Society of America for credits towards Star Ratings, Who's Who in Photography, and distinctions of PPSA and EPSA.
14. An illustrated catalog will be sent to each entrant.

Note to overseas entrants: please enclose two return address labels with your entry.

COMPETITION RULES

● Color Slides and Photojournalism (P-J) Slides

1. Up to four slides may be entered in each of these sections, and they may be mailed in one package.
2. Only 2x2 inch (5x5 cm) mounts are eligible and they must drop freely from a universal Kodak Carousel 80 slide tray.
3. Slides must be marked with a dot in the lower left-hand corner as hand viewed.
4. All slides will be returned by First Class Mail. For priority or other special handling, include instructions and appropriate additional fees.

● Class A Pictorial Color Prints and Monochrome Prints

1. Up to four prints may be entered in each of these sections and they may be mailed in one package.
2. Class A prints must be processed by the maker, mounting excluded. A monochrome print is defined as having no more than two colors: monochrome plus one other color. Hand colored monochrome prints with more than one additional color shall be entered in the Color Print Section.
3. Prints from the United States, Canada, and Mexico, may be shipped mounted or unmounted. Ship prints from all other countries flat and unmounted.
4. Prints must not exceed 16x20 inch (40x50 cm), mount included. Mounted prints should be on a single weight, approximately 1/16 inch (1.5 mm) thick mat board.
5. Name, identifying mark, or words in any language may not be added to the front of the print or mat.
6. Prints will be returned by UPS, USPS, or as Printed Matter for overseas entries, unless otherwise specified and accompanied by the additional postage.

● Class B Pictorial Small Prints

1. Class B Pictorial Small prints must not exceed 8 ½ x12 inch (21x30 cm), including the mount. The prints may be commercial or self printed. Four color prints may be entered in this section.
2. Entrants are now allowed to enter both Class A and Class B Pictorial Small Prints.
3. Rules 3, 5, and 6, under Class A pictorial prints also apply.

● General Photojournalism (P-J) Prints

1. Prints may be processed by the maker or commercially processed and must not exceed 8 ½ x12 inches (21x30 cm) including the mount.
2. Up to four prints may be submitted in this section; color, monochrome, or mixed.
3. Rules 3, 5, and 6, under Class A pictorial prints also apply.

Photojournalism Special Instructions

Photojournalism entries shall consist of pictures or sequences with informative content and emotional impact, including human interest, documentary and spot news. The journalistic value of the photograph shall be considered over pictorial quality. **In the interest of credibility, photographs which misrepresent the truth, such as manipulation to alter the subject matter, or situations which are set up for the purpose of photography, are unacceptable in Photojournalism competition.** Print and slide sequences may be entered by placing more than one picture in a single mount.

Postage Surcharges For Return Of Entries:
For international print returns by Global Air Mail Parcel Post, the appropriate extra charge must be determined and included with the entry. (To determine amount, refer to: www.USPS.com)

Fees are payable in **US currency** or by a check that can be cleared through a US bank. Make checks and money orders payable to the **Delaware Photographic Society**. Foreign checks or money orders are acceptable only if payable in United States currency and if they can be cleared through a US Bank. Where government regulations prohibit the transfer of funds outside of a country, International Reply Coupons (IRC) of equivalent value should accompany the entry. IRC's are available through the post office. An entry received without the required fee will not be processed, but will await payment until the closing date. We now accept **PayPal** for payment at an additional cost of \$0.75 per transaction. Refer to DPS Web site for details.

If no fee is received, the entry will neither be judged nor returned to the entrant.

AWARDS

PHOTOGRAPHIC SOCIETY OF AMERICA MEDALS

Special Recognition for efficient management has been received from the Photographic Society of America (PSA). Engraved PSA medals will be awarded by the judges:

- PSA Gold Medals for "Best in Show" in the following categories: Color Slide, Class A Monochrome Print, Class A Color Print, Class B Pictorial Small Print, Photojournalism Print and Photojournalism Slide.
- PSA Creative Medals in the following categories: Gold Medal in Color Slide, Silver Medals in Class A Pictorial Monochrome Print, Class A Color Print, and Class B Pictorial Small Print. Creative photography is defined as "altered reality".
- PSA Silver Medals for "best human interest" in Photojournalism Slides and Photojournalism Prints. Human Interest is defined as "an image depicting a person or persons, excluding sports action."
- One PSA Mid-Atlantic Chapter Gold Medal will be awarded in each category.

DELAWARE PHOTOGRAPHIC SOCIETY AWARDS

The Delaware Photographic Society will award appropriately engraved Gold Medals for outstanding photographs in all six categories: Color Slides, Class A Monochrome/Color Prints, Class B Pictorial Small Prints, and Photojournalism Slides/Prints. The DPS will also award three Bronze Judge's Choice Medals in each section, and Silver Medals and Honor Ribbons based on the number of entries and the judges' discretion.

IIFW (INTERNATIONAL ASSOCIATION OF COMPETITION PHOTOGRAPHERS)

Five Gold Medals will be awarded for Class A Pictorial Color Print, Class A Pictorial Monochrome Print, Class B Pictorial Small Print, PJ Print, and PJ Slide.

JENDROSZEK MEDAL

The Alfred Jendroszek Medal will be awarded to an outstanding Color Slide.

DELAWARE VALLEY COUNCIL OF CAMERA CLUBS (DVCCC)

DVCCC will donate six medals, one in each section, for the best image by a local entrant who is not awarded another medal in that section. Eligibility is extended to all paid members of clubs that belong to the council as of December 31, 2006 and this must be indicated on the entry form.

SOUTH JERSEY CAMERA CLUB (SJCC)

SJCC donates a Gold Medal to the outstanding Nature Slide in the Color Slide section.

FFC-BAYER AWARDS

Three medals will be donated, one in each pictorial print section, by Judge Klaus Strehlke.

PEOPLE'S CHOICE AWARDS

Attendees at the exhibition are invited to vote for two prints, one by a local photographer and one by a non-local photographer as their personal favorites. The two prints receiving the most votes are awarded "People's Choice" medals and are listed in the following year's catalog.

ASSOCIATES and FELLOWS

Honors are earned through accumulated WIEP jury acceptances of prints and slides compiled annually. Ten acceptances over the current ten year period are required for Associate (AWIEP) membership. Associates achieve Senior (SAWIEP) status with ten additional acceptances, for a total of twenty, without time limitation. Associates who accumulate 50 or more acceptances are named Fellows (FWIEP) of the exhibition, and those who achieve 100 or more acceptances are awarded the title of Senior Fellow (SFWIEP), an engraved tray, and future entry without fee.
